

## MARYGROVE COLLEGE TEACH GRANT APPLICATION 2012-2013

TEACH Grant is a federal grant program aimed at increasing the number of full-time certified teachers in the Bilingual Education, Foreign Language, Math, Reading Specialist, Science, and Special Education.

Undergraduate and graduate students working toward a first Bachelors or Masters degree leading toward teacher certification in one of these high need areas, may be eligible for the TEACH Grant at Marygrove College with a 3.25 cumulative GPA. POST DEGREE STUDENTS working on teacher certification, special education endorsement/certificate, reading specialist and MAT/TEACHSCAPE students are NOT eligible for the TEACH Grant.

The TEACH Grant awards up to \$4,000 per academic year for up to 4 years for undergraduates, and 2 years for graduate students. The award is prorated based on actual enrollment. There is no minimum enrollment level required and the student must be making SAP to be eligible.

To be considered for the TEACH Grant for the 2011-2012 Academic year, please complete the following. **ALL DATA ELEMENTS AND SIGNATURES ARE REQUIRED.** You will be notified of your award status on or after October 1, 2012.

| MY SIGNATURE BELOW MEANS THAT I HAVE FULLY READ AND UNDERSTAND that students receiving the TEACH Grant must complete TEACH Grant Counseling and sign an Agreement to Serve (ATS) each academic year prior to disbursement. Students must teach full-time in one of the high need areas at a low-income (Title 1) school district for four years within eight years of completing the certification. Students who fail to meet the terms of the service agreement will prompt the TEACH Grant awarded to convert to a Federal Direct Student Unsubsidized Loan with interest accrued as of the first disbursement. Once the TEACH Grant has converted to a loan, it can NOT be returned to a "grant" status. The student may request that the TEACH Grant be converted to a loan at any time.
